
PRE-ASSESSMENT LETTER OF ACKNOWLEDGEMENT

SANAS PRE-ASSESSMENT LETTER OF ACKNOWLEDGEMENT

1. The Pre-assessment Letter of Acknowledgement only serves to confirm that the applicant organisation has been pre-assessed by SANAS and issued under condition that the applicant obtains full accreditation status within **4 months** from the date of accepting these conditions.
2. SANAS Pre-assessment Letter of Acknowledgement does not grant an organisation the authority to claim accreditation nor does it give permission to use the SANAS accreditation symbol or any reference that might create the impression that the organisation is accredited.
3. It is the applicant organisation's responsibility to inform SANAS of its readiness for initial SANAS assessment.
4. The SANAS initial assessment must be conducted within 2 months of receipt of Pre-assessment Letter of Acknowledgement, to allow sufficient time for the SANAS administrative processes to be completed.

8. The validity period of the Pre-assessment Letter of Acknowledgement will not be extended under any circumstances.
